Inigo Jones and recreating the antique

2:00- 2:30 – Hentie Louw FSA, ‘Inigo Jones and the search for a Modern Classical Window’

Hentie Louw qualified as an architect in South Africa before moving to Europe. He studied under Bruce Allsopp and Howard Colvin and taught architecture at Newcastle University till retirement in 2012. His research interests span architectural & construction history, specializing in historic window design and related industries of the post-medieval period in Western Europe.

Dr Jane Spooner (jane.spooner@hrp.org.uk) is Head of Historic Buildings at Historic Royal Palaces, managing a team of curators. Prior to this she was the Historic Buildings Curator for the Tower of London for fifteen years, and continues to have responsibility for the Banqueting House, Whitehall. Jane trained as an art historian and as a wall paintings conservator, and specialises in the material history of wall paintings.

Nicholas Cooper retired in 1999 from a long career with the Royal Commission on Historical Monuments, and served for many years on the Architectural Panel of the National Trust. He has published extensively, mainly on the early modern period and the 19th century. He is a Fellow of the Society of Antiquaries, and of the Royal Historical Society.
